

*Liability Waiver*  
**JUMP –N- PARTY**

I represent that I am the parent or legal guardian of the child or children listed below or have obtained permission from the parent/legal guardian of child or children listed below and execute this agreement on their behalf. I agree that the participant(s) named below and I shall comply with all stated and customary terms, posted safety signs, rules and verbal instructions as conditions for participation in any party, program and/or use of the play area and inflatable equipment at Jump –N- Party. In addition, if I observe any hazard during our participation, I will bring it to the attention of the nearest Jump N- Party employee or official immediately.

**I am aware that there are inherent risks, including but not limited to the risk of serious injury or death, associated with participation in Jump –N- Party programs, parties, and/or use of the play area and inflatable equipment and I, on behalf of myself and the participant(s) named above, knowingly and freely assume all such risks, both known and unknown, including those that may arise out of the negligence of other participants.**

In consideration of being allowed to use the facilities of Jump –N- Party:

I agree that I will not sue, or otherwise make any claim against Jump – N – Party, any other sponsors/providers, or their employees, agents, and contractors, for any loss, injury or damage resulting from participation in any party, program and/or use of the play area and inflatable equipment.

I agree that Jump – N – Party, any other sponsors/providers, and their employees, agents and contractors, shall not be legally responsible for any loss, injury or damage resulting from any cause, including negligence of any party.

To the fullest extent allowed by law I agree to RELEASE, INDEMNIFY and HOLD HARMLESS Jump –N- Party, any other sponsors/provider, their employee, agents, and contractors from all actions, suits or claims, including attorney’s fees, from myself and/or the participant(s) and our heirs or personal representatives for any loss, injury, or damage resulting from participation in any party, program and/or use of the play area and inflatable equipment at Jump –N- Party.

In the event of injury, damage or loss due to Jump – N – Party’s negligence, I agree and assume the duty to mitigate all costs resulting from said injury, damage or loss.

By signing this contract, I agree to forego seeking any consequential damages in the event of any injury, damage or loss due to Jump – N – Party’s negligence.

The terms of this Release shall also be binding as to any other persons, including all family members, heirs, executors, or administrators, and including any minor which may accompany me. I understand this is a binding contract that supersedes any other agreements or representations, and is intended to provide a comprehensive release of liability but is not intended to assert any defenses which are prohibited by law. If any part of this Release is deemed unenforceable, all other parts shall be given full force and effect. I am legally competent to sign this Release or my parent or legal guardian has also read and signed this release.

**I HAVE CAREFULLY READ AND FULLY UNDERSTAND THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. I SIGN THIS RELEASE AGREEMENT OF MY OWN FREE WILL AND INTEND MY SIGNITURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.**
